

\$10 Consumer Mail-In Rebate on the purchase and installation of an ACDelco Advantage or Professional Battery

To receive your GM Parts Rebates Visa[®] Prepaid Card by mail, follow these conditions of acceptance:

(Submission must be postmarked by March 31, 2018.)
