

# GM Parts Non-Authorized Customer List

On November 1, 2019, General Motors Customer Care and Aftersales division (“CCA”) announced the implementation of an Electronic Minimum Resale Price (“EMRP”) policy effective January 1, 2020 for all resellers of the EMRP covered products. Details of the policy, the covered parts and the EMRP level pricing can be found at [www.GMPartsEMRP.com](http://www.GMPartsEMRP.com).

On an ongoing basis, GM will publish a Non-Authorized Customer List as detailed in the EMRP Policy Statement. This list is comprised of reselling entities that are in violation of the GM Parts EMRP policy and therefore are subject to the consequences as outlined in the policy. Bear in mind that under the GM Parts EMRP policy, Dealers and Resellers (as defined in the policy) are responsible for informing their retailers of the policy. Dealers and Resellers that sell to any entity on this list after the effective date noted below are subject to enforcement as outlined in the policy.
